About the Symposium

An alcohol ignition interlock is a breath-testing device designed to prevent drivers who have been drinking from starting their vehicle when their breath alcohol concentration is above a pre-set limit.

A large body of research evidence exists that demonstrates the effectiveness of these devices in preventing drinking and driving.

When embedded in a well-designed program, alcohol ignition interlocks can reduce impaired driving and prevent repeat offenses. In more recent years, there is also convergence of evidence from independent sources showing that interlocks can reduce crashes and fatalities.

Since 2000, the international Alcohol Interlock Symposium has hosted leading experts to discuss ongoing research and development regarding alcohol and drug impaired driving, interlock programs, and road safety.

The Traffic Injury Research Foundation (TIRF) has organized and hosted the international symposia series on alcohol interlocks in partnership with government agencies in different jurisdictions.

Continuing a growing interest in the benefits of implementing interlock programs as effective road safety measures in Norway, TIRF joins efforts at local level with the Norwegian Alcohol Interlock Committee to stage this year's symposium in Oslo. In addition, the event's content will be further broadened and enriched by the participation of the European Transport Safety Council (ETSC) as a co-host. ETSC is a Brussels-based independent non-profit making organisation dedicated to reducing the numbers of deaths and injuries in transport in Europe.
