










## **EU ROAD MORTALITY 2022 AND 2012**



#### **EU GENERAL SAFETY REGULATION**

- A standardised interface that facilitates the fitting of aftermarket alcohol interlock devices in motor vehicles required for all new type approved vehicles as of mid-2022 and all new vehicles as of mid-2024
- Reference to the European standard on alcohol interlocks (EN 50436)
